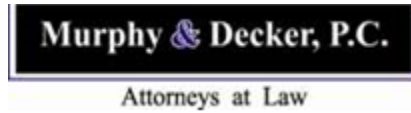

I was talking to Scott Riley of WJE earlier this week and asked him when he thought the remediation project had to get underway in order to allow the County enough time to move into the building before the start of the Weston County Fair.
