Hi, all,
I don't have Bill Lambert's email address so could not include him on this email. Cheryl, would you see that this is copied to him as well? I appreciate the information from CWCSWDD. We have recorded a liability of the \$890,120, currently based on the documentation we received from CWCSWDD and the DEQ. That still does not allow us to remove the qualification on our report since DEQ has said their number is an estimate and you would need to get an assessment from an engineer of the actual costs to

close. If you send us documentation of the engineer's monitoring costs and the number of years that the monitoring needs to be performed, then we can definitely add the \$1-1.7 million for the monitoring costs. However, we will still would have a qualification related to the closure costs.

Please send that documentation showing the \$54,950.71 and the number of years that this post-closure monitoring will need to continue and we will be happy to book that additional liability before we release.
