# Official Minutes February 2, 2016

The Weston County Board of Commissioners convened at 9:00 a.m., Chairman Bill Lambert presiding. Present were Commissioners: Tony Barton, Marty Ertman, Tracy Hunt, Randy Rossman, Administrative Assistant Dan Blakeman and County Clerk Cheryl Kregel.

#### Good of the Order

Commissioner Rossman gave the Invocation and Commissioner Barton led in the Pledge of Allegiance. <u>Approval of Agenda</u>

Commissioner Barton moved and Commissioner Rossman seconded to add three items to New Business: Predatory Animal Board Appointment, discussion on the Weston County Fairgrounds and their new fees and discussion on a Mission Statement for the Commissioners. Carried.

### **Budget Hearing Amendment**

The hour being 10:00 a.m., Chairman Lambert opened the hearing for the budget amendment. Chairman Lambert called three times for public comments. There being no public comments, the public hearing portion of the budget amendment hearing was closed. Commissioner Rossman moved and Commissioner Hunt seconded to approve the budget amendment to increase the General Fund portion of the budget by \$32,739.24 because of unanticipated grant amendment from the Federal Aviation & Administration (FAA), for the Mondell Airport Improvement Project Masterplan Airport Runway Extension 2012 and allocate monies to expenditure account 300.00.40.0255000.0000. Also, to increase the budget by \$37,369.00 for a grant awarded from the U.S. Department of Homeland Security (DHS) Federal Emergency Management Agency (FEMA), Grant Programs Directorate, State Homeland Security Program (SHSP) Grant Fiscal Year 2015 to expenditure account 515.10.87.0104000.0517. Carried.

The meeting recessed at 10:04 a.m. and resumed at 10:10 a.m.

### **Approval of Consent Agenda**

Commissioner Barton moved and Commissioner Rossman seconded to approve the consent agenda including the AP vouchers and Payroll report, District Courts monthly statement \$1,652.97 and the County Clerks monthly statement \$9,910.00, the Chairman's signature on Resolution 16-01 Upton Meeting on July 19, 2016 and for the State Hazard Mitigation for Homeland Security, minus Voucher #59993 and the minutes from January 19, 2016. Carried.

Commissioner Barton moved and Commissioner Ertman seconded to approve the minutes for January 19, 2016 with the following changes in the Set Budget Hearing adding the words "to hold a budget hearing to increase", in New Business change January 1, 2017 to January 2, 2017 also add IRS Mileage Rate that went into effect starting January 1, 2016". Carried.

### New Business

Commissioner Rossman moved and Commissioner Ertman seconded the reappointment of Joseph Cummings to the Central Weston County Solid Waste Disposal District Board for 2016-2020. Carried. Weston County Predatory Animal Control Board has one applicant which the Commissioners will run by County Attorney William Curley and visit with the Predatory Board. This decision will be made at the next meeting. Commissioner Rossman moved and Commissioner Ertman seconded to accept the resignation of Mike Davis from the Weston County Weed and Pest Board. Mr. Davis will be receiving a Thank You letter for his service to board. Carried.

Commissioner Rossman moved and Commissioner Ertman seconded to approve to renewal dues of \$100.00 for the Black Hills Regional Multiple Use Coalition. Carried.

Commissioner Rossman brought up the new fees being charged by the Weston County Fair Board. Discussion was heard and the Commissioners will be in touch with the WC Fair Board to invite them to a meeting. Discussion was also heard on creating a Mission Statement for the County Commissioners which was an idea brought up at the recent Board Training.

#### **Old Business**

Commissioner Rossman updated the Board on Commissioner Ertman and his progress in coming up with a process to evaluate Homeland Security person.

After discussing the possible future needs of the Coroner. Commissioner Hunt moved and Commissioner Rossman seconded to transfer \$10,000.00 from Gen. Misc. Fin. Administrative line item 100.00.20.0099000.0000 in to a new line item Gen. Coroner Inquest & Investigation 100.00.09.0028000.0000. Carried.

Fran Lehman, GIS Coordinator meet with the Commissioners stating she had sent another letter to Black Hills Bentonite Plant and they had send a letter asking to withdraw the application.

Chairman Lambert updated the Board on meeting with George Byers, Vice-President of Government & Community Relations for Rare Element Resources Inc. The Draft EIS for the Bear Lodge Project was discussed.

Commissioner Rossman moved and Commissioner Ertman seconded for the Chairman to sign the Regional Mitigation Planning letter which was brought before the Board previously. Carried.

### Administrative Assistant Update

Dan Blakeman, Administrative Assistant gave an update on information from SLIB, the new phone system for the main floor of the Courthouse, bid packets will be available soon for the Road & Bridge shop floor and the Law Enforcement Center for the roof. The County will be paying contractors immediately for completion of work with proper authorization. Mr. Blakeman discussed a letter from WYDOT which explained how payments from that office with be dispersed. Payments from WYDOT are a on a reimbursement basis which is the same procedure as those coming from the State Land and Investment Board. A discussion ensued to ensure that contractors would be paid by the county as per its standard procedure instead of payments being back waiting for payments from WYDOT and/or SLIB.
