Official Minutes April 5, 2016

The Weston County Commissioners convened at 9:00 a.m. with Chairman Lambert presiding. Present were Commissioners: Marty Ertman, Randy Rossman, Tracy Hunt, Tony Barton, Administrative Assistant Dan Blakeman and County Clerk Cheryl Kline.

Good of the Order

Commissioner Rossman gave the Invocation and Commissioner Ertman led in the Pledge of Allegiance.

Approval of Agenda

Commissioner Hunt moved and Commissioner Rossman seconded to approve the agenda. Carried.

Approval of Consent Agenda

Commissioner Hunt moved and Commissioner Barton seconded to approve the consent agenda including the Executive Session Minutes from March 15, 2016, AP & Payroll Reports, District Court Statement \$1,426.50 and the County Clerk Statement \$9,651.50 and the approval of the signature of Chairman Lambert on the Flying V Liquor Licenses, with the removal of the minutes from March 15, 2016. Carried. Commissioner Ertman moved and Commissioner Rossman seconded to amend the minutes as follows: under Transfer of Limited Retail-Club Liquor License Hearing "The Commissioners will be advertising for an available Retail Liquor License." End the sentence with a period. And then "The license will be available for a period of one year from July1, 2016 to June 30, 2017". Under FY 2016-2017 Budget Letter "Provider of Service" instead of Service of Provider. Carried.

Vouchers

Commissioner Barton moved and Commissioner Ertman seconded to approve the Vouchers excluding warrants 60304 for \$25.00 to Newcastle Chamber of Commerce and 60311 for \$35.00 to Pennington County and discussion was heard on Black Hills Plumbing & Heating Voucher pertaining to Fire Inspections at the Weston County Library and the Weston County Law Enforcement buildings. The invoice will be billed to each entity from Black Hills Plumbing & Heating. Carried. Commissioner Rossman moved and Commissioner Ertman seconded to accept the letter of resignation of Ellen McKenzie from the Weston County Fair Board and to advertise for the position in the *Weston County Gazette* and the *News Letter Journal*, also send a Thank You letter to Ms. McKenzie for her past service. Motion carried. Discussion on the Wyoming Department of Family Services sent TANF/CPI Application. Commissioner Ertman will be visiting with Public Health Nurse Lori Bickford on this application. Commissioner Ertman moved and Commissioner Rossman seconded to support the Northeast Wyoming Economic Development Coalition (NEWEDC). Commissioner Barton voted "Yea" and Commissioners Ertman, Rossman, Hunt and Lambert voted "Nay". Motion failed. The Wyoming Highway patrol and the Wyoming Office of Homeland Security will be offering various Work Place Safety Trainings throughout the state of Wyoming. Courthouse employees will be going to the April 26, 2016 training in Gillette. The meeting recessed at 11:09 a.m. and resumed at 11:15 a.m.

Chairman Lambert opened the floor to public comments. There were none heard at this time.

Weston County Attorney Update

William Curley, Weston County Attorney, visited with the Commissioners on Title 25 procedures. Commissioner Barton moved and Commissioner Rossman seconded to authorize the signature of the Chairman on Resolution No. 2016-04 Establishing A Single Point of Responsibility Pursuant to Wyoming Statute 25-10-112(g). Carried. Commissioner Ertman moved and Commissioner Rossman seconded to approve the signature of the Chairman for Weston County Road Identification Project 001 Resolution 2016-05 initiating Identification of County Roads in T48N R68W and T47N R68W and to advertise the *Weston County Gazette*. Discussion was heard. Commissioner Barton moved to amend the motion to include Mr. Curley doing a press release in the *Weston County Gazette* and the *News Letter Journal*. Commissioners Lambert, Barton, Hunt and Rossman voted "Yea" and Commissioner Ertman voted "Nay". Carried. Also discussed was a letter pertaining to John and Sharron Ackerman's county road easement from their Attorney Anthony Wendtland. A walk around the property is set for the middle of April. No action was taken.

Four Corners Petroleum

Treasurer Susan Overman met with the Board on cancelling the first half of interest on 2015 paid taxes that accrued with Four Corners Petroleum, LLC due to discrepancies between districts on an amended return filed with Wyoming Department of Revenue. Commissioner Ertman moved and Commissioner Rossman seconded to approve the forgiveness of the interest of \$1366.00 to Four Corners Petroleum. Carried.

The meeting recessed at 1:24 p.m. and resumed at 1:30 p.m.

Weston County Homeland Security

Commissioner Barton moved and Commissioner Ertman seconded to approve the signature of the Chairman for Resolution 16-06 Designation of the National Incident Management System (NIMS). Discussion was heard. Commissioners Ertman, Barton and Rossman voted "Yea" and Commissioners Hunt and Lambert voted "Nay". Motion Carried.

Weston County Solid Waste District Board Update

Ed Wagoner, Board Member of the Weston County Solid Waste District Board updated on the Commissioners on the progress with the landfill issues.

Setting Budget Amendment Hearing

Commissioner Ertman moved and Commissioner Rossman seconded to set a Budget Amendment Hearing to increase account 413.50.44.0078000.0000 which is the County Road Construction Fund for \$40,000.00. Motion carried.

FY 2016-2017 Budget

The Commissioners discussed the upcoming FY Budget 2016-2017.

Weston County Road & Bridge Update

Rick Williams, Supervisor of Road & Bridge updated the Commissioners on various projects.

Weston County Bruce Road Dust Control Project

Jerry Hunt, Weston County Engineer, presented the four bid tabs which were submitted on the Weston County Bruce Road Dust Control Project. The lowest bid was Timberline Services, Inc with \$97,112.50, second: Dan Hart Patrol Services, LLC with \$116,307.50, third: Farnsworth Services Co, Inc with \$124,782.50, fourth, Warren Transport, Inc. with \$138,053.17. Commissioner Barton moved and Commissioner Rossman seconded to award the Weston County Bruce Road Dust Control Project to Timberline Services, Inc. in the amount of \$97,112.502. Discussion was heard. Motion carried.

Administrative Assistant Update

Dan Blakeman, Administrative Assistant updated the Commissioners on the WC Event Center. Commissioner Barton moved and Commissioner Lambert seconded to authorize the signature of the Chairman on the Powder River Heating and Air Conditioning proposal bid of \$8,830.00 for removal and replace ceilings, build ductwork on first floor, build piping chase on second floor and repair walls behind three fan coils removed on first floor and the alternate #1 bid on the main floor for the removal of eight (8) Fan coil units at \$480.00 each. Carried. Commissioner Barton moved and Commissioner Rossman seconded to approve Re-allocating \$20,586.95 of CWC#13102 for the Courthouse lightening project to CWC#11182 for the Courthouse HVAC project per the approval of State Land Investment Board and the other two entities of Newcastle and Upton. Carried. Weston County Youth Building roof was discussed and the Commissioners will visit with the Weston County Fair Board on ideas for repairing the roof.

Executive Session

Commissioner Rossman moved and Commissioner Hunt seconded to go into executive session under W.S. 16-4-405 (a) (ii), to consider the appointment, employment, right to practice or dismissal of a public officer, professional person or employee, or to hear complaints or charges brought against an employee, professional person or officer requests to a public hearing. The governing body may exclude from any public or private hearing during the examination of a witness, any or all other witnesses in the matter being investigated. Following the hearing or executive session, the governing body may deliberate on its decision in executive session. Carried.
