### **Sheriff's Department**

Bryan Colvard, County Sheriff, met with the Commissioners and discussed accounts receivable for the department. Sheriff Colvard informed the Commissioners that the insurance company will send an engineer to inspect the Law Enforcement Center on July 10, 2013, as part of a prior water damage claim. Sheriff Colvard discussed the Emergency Operations Center (EOC) remodel. Changes to the EOC including the addition of a Circuit Court space will increase the remodel costs due to building code regulations. No action was taken.
