December 3, 2013

The regular meeting of the Weston County Commissioners convened at 9:00 a.m. with Chairman Seeley presiding. Present for the meeting were Commissioners: Lenard D. Seeley, Jerry Shepperson, Randy Rossman, Marty Ertman, Tracy Hunt and County Clerk, Mamie C. Krank.

Invocation and Pledge of Allegiance

Commissioner Shepperson gave the Invocation and Commissioner Ertman led the delegation in the Pledge of Allegiance.

Approve Minutes

A motion was made by Commissioner Shepperson, seconded by Commissioner Rossman, to approve the minutes of a special meeting held November 19, 2013 and the minutes of the regular meeting held November 21, 2013, as published. Carried.

Board Appointment Hearing

A motion was made by Commissioner Hunt, seconded by Commissioner Shepperson, to set a January Board Appointment Hearing for January 7, 2014 at 10:00 a.m. Carried.

Rebate of Taxes

A motion was made by Commissioner Rossman, seconded by Commissioner Hunt, to accept three (3) Rebates of Taxes in the following particulars: Rebate numbered 1079 to Rock Well Petroleum in the amount of \$4,971.49; Rebate numbered 1080 to POC-1, LLC in the amount of \$10,853.86 and Rebate numbered 1081 to POC-1, LLC in the amount of \$15,880.55. Carried.

Budget Reports

A motion was made by Commissioner Rossman, seconded by Commissioner Shepperson, to approve and sign the Budget Reports as presented for November 2013. Carried.

Weston County Extension Rental Agreement

A motion was made by Commissioner Rossman, seconded by Commissioner Ertman, to authorize Chairman Seeley's signature on a collection agreement between Weston County and the Forest Service for the Ag Extension Office space rental, for Fiscal Year 2014. The agreement is in the amount of \$15,827.00 which is the same as last years' agreement. Carried

The meeting recessed at 9:50 a.m. and reconvened at 10:00 a.m. with all present.

2014 Legal Newspaper

A motion was made by Commissioner Shepperson, seconded by Commissioner Rossman, to authorize Chairman Seeley's signature on letters requesting quotes from the News Letter Journal and the Weston County Gazette for Weston County's 2014 legal newspaper. Carried.

Manual Checks

A motion was made by Commissioner Rossman, seconded by Commissioner Shepperson, to approve the manual checks for November 2013 as presented. Carried.

Mondell Airport Runway Project

A motion was made by Commissioner Shepperson, seconded by Commissioner Hunt, to authorize a reduction in retainage from ten percent to five percent for DRM, Inc., contractor for the Mondell Airport Runway Project; and authorize Chairman Seeley's signature on a letter to First Northern Bank of WY requesting a five percent payment be made to DRM, Inc. Discussion ensued, carried. The recorded votes are as follows: Yea: Commissioners Shepperson, Hunt and Rossman; Nay: Commissioner Ertman.

Budget Amendment Hearing LEPC

The hour being 10:15 a.m., Chairman Seeley opened a Budget Amendment Hearing to consider increasing the Fiscal Year 2014 budget by a total of \$2,109.17 for the Homeland Security Local Emergency Planning Committee (LEPC) Grant. The federal portion of the grant is \$1,687.34 and the local match would be \$421.83. Chairman Seeley called for public comment, hearing none; the public comment portion of the hearing was closed at 10:16 a.m. A motion was made by Commissioner Shepperson, seconded by Commissioner Rossman, to approve the

budget amendment for Homeland Security LEPC in the amount of \$2,109.17. Carried. The Budget Amendment Hearing was closed at 10:17 a.m.

Secure Rural Schools Funding

A motion was made by Commissioner Shepperson, seconded by Commissioner Rossman, to authorize Susan Overman, Treasurer, to send a request for Weston County's portion of the Secure Rural Schools (SRS) funding. Carried.

Accept Collections

A motion was made by Commissioner Rossman, seconded by Commissioner Shepperson, to accept the collections of the District Court in the amount of \$2,340.42. Carried.

A motion was made by Commissioner Shepperson, seconded by Commissioner Rossman, to accept the collections of the County Clerk in the amount of \$9,643.75. Carried.

Weston County Health Services

Barry Peterson, Weston County Health Services (WCHS) Treasurer, met with the Commissioners and presented the facilities yearly update. Among the topics discussed were the recent implementation of electronic medical records, long term care at the Manor facility, the possibility of a retail pharmacy at WCHS and the pending implementation of ICD-10 which will provide more accurate patient diagnosis. No action was taken; Mr. Peterson was thanked for his presentation.

The meeting recessed at 11:07 a.m. and reconvened at 11:15 a.m. with all present.

Public Funds Banking Resolution

A motion was made by Commissioner Rossman, seconded by Commissioner Shepperson, to authorize Chairman Seeley's signature on a Public Funds Banking Resolution for the Weston County warrant account at First State Bank of Newcastle. Carried.

The meeting recessed at 11:30 a.m. and reconvened at 1:30 p.m. with all present.

Contract Engineer

Jerry Hunt, Weston County Contract Engineer, met with the Commissioners and discussed the completed contract drawn up for the Road & Bridge old shop roof project. This project will be advertised for bid; bids will be opened on January 7, 2014 at 2:00 p.m. during the Commissioner's Meeting.

Event Center: Mr. Hunt stated that he had inspected the drainage repairs at the Weston County Event Center completed by the Road & Bridge department and would re-visit the site to address concerns.

Basement Floor/Courthouse: Mr. Hunt stated that damage to the basement floor may have been caused by this year's water events, however; more investigation would be needed before a solution could be reached. Mr. Hunt requested permission to pull up some carpet in Fran Lehman's office, the Commissioners agreed that Mr. Hunt should investigate and report back.

Mallo Camp Lodge Lighting: Mr. Hunt stated that Mallo Camp Lodge needs approximately ten (10) eight foot long florescent lights in the kitchen area and the same number in the main lodge replaced. Mr. Hunt discussed progress on the County Building Energy Efficient Lighting Project bid packet. No action was taken; the Commissioners thanked Mr. Hunt for the information.

Prairie Dogs

Bob and Jean Harshbarger, resident experts, met with the Commissioners and discussed prairie dog issues and provided a proposed resolution for the Commissioners consideration.

The meeting recessed at 2:33 p.m. and reconvened at 2:38 p.m. with all present.

After review and revision of the proposed resolution; a motion was made by Commissioner Shepperson, seconded by Commissioner Ertman, to adopt and authorize Chairman Seeley's signature on Resolution 13-03 which deals with Forest Service adherence to Federal Regulations and the Nation Environmental Protection Act (NEPA) Process. Discussion ensued, carried.

County Administrator Position

The Commissioners discussed the county administrator position and reviewed materials provided by Bill Miller of the Local Government Liability Pool (LGLP). Mamie C. Krank, County Clerk, will review the draft job description with Mr. Miller and report back to the Commissioners. No action was taken.
