The undersigned requests personal motor vehicle record information on the indicated person or motor vehicle, and *hereby certifies* the information is subject to disclosure for the purposes identified in the noted subsection of 18 USC ss2721 (*please circle all applicable subsections*):

- (b) For use in connection with matters of motor vehicle or drivers' safety and theft, motor vehicle emissions, motor vehicle product alterations, recalls or advisories, performance monitoring of motor vehicle and dealers by motor vehicle manufacturers, and removal of non-owner records for the original records of motor vehicle manufacturers to carry out the purposes of the Automobile Information Disclosure Act, the Motor Vehicle Information and Cost Saving Act, the National Traffic and Motor Vehicle Safety Act of 1966, the Anti-Car Theft Act of 1992 and the Clean Air Act:
- (b)(1) For use by any government agency including any court of law enforcement agency in carrying out its functions, or any private person or entity acting on behalf of a federal, state or local agency in carrying out its functions:
- (b)(2) For use in connection with matters of motor vehicle or drivers' safety and theft, motor vehicle emissions, motor vehicle product alterations, recalls or advisories; performance monitoring of motor vehicles, motor vehicle parts and dealers; motor vehicle market research activities, including survey research, and removal of non-owner records from the original owner records of motor vehicle manufacturers:
- (b)(3) For use in the normal course of business by a legitimate business or its agents, employees or contractors, but only –
  - (A) To verify the accuracy of personal information submitted by the individual through the business or its agents, employees or contractors: and
  - (B) If such information as so submitted is not correct or is no longer correct to obtain the correct information, but only for the purposes of preventing fraud, by pursuing legal remedies against or recovering on a debt or security interest against, the individual.
- (b)(4) For use in connection with any civil, criminal, administrative or arbitative proceedings in any federal, state or local court or agency or before any self regulatory body, including the service of process, investigation in anticipation of litigation, any execution or enforcement of judgements and orders or pursuant to an order of a federal, state or local court:
- (b)(5) For use in research activities, and for use in producing statistical reports, so long as the personal information is not published, redisclosed, or used to contract individuals:
- (b)(6) For use by any insurer or insurance support organization or by a self-insured entity or its agents, employees or contractors in connection with claims, investigation activities, anti-fraud activities, rating or underwriting:
- (b)(7) For use in providing notice to the owners of towed or impounded vehicles:
- (b)(8) For use by any licensed, private investigative agency or licensed security service for any purpose permitted under this sub-section:
- (b)(9) For use by an employer or its agent or insurer to obtain or verify information relating to a holder of a commercial drivers license which is required under the Commercial Motor Vehicle Safety Act of 1986 (49 USC app 2710 et seq.):
- (b)(10) For use in connection with the operation of private toll transportation facilities;
- (b)(13) For use by any requestor, if the requestor demonstrates it has obtained the written consent of the individual to whom the information pertains:
- (b)(14) For any other use specifically authorized under the law of the state that holds the record if such use is related to the operation of a motor vehicle or public safety.

Requests pursuant to 18 USC ss 2721 (b)(10) and ss (b)(11) should be directed to the Wyoming Department of Transportation to insure personal information is not disclosed for any person having filed the appropriate documentation to prohibit disclosure.
