## RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS WESTON COUNTY, WYOMING FOR THE CREATION OR ESTABLISHMENT OF A PORTION OF THE MUSH CREEK ROAD

Whereas, Weston County, Wyoming, is committed to identifying and correctly locating its county roads, and

Whereas, this process has revealed that a portion of the Mush Creek Road does not lie entirely within the legal right-of-way of the Road, and

Whereas, the Board of County Commissioners of Weston County, Wyoming has caused an accurate survey of the Mush Creek Road to be made and a plat of the Road to be prepared, which plat and surveyor's notes are recorded in the office of the County Clerk of Weston County, Wyoming, in Plat Cabinet 2, Pages 15,16,17 and 18 as required by law, and

Whereas, the Board of County Commissioners of Weston County, Wyoming, based upon the doctrines of adverse possession or prescription, desires to establish the location of the Mush Creek Road so that the right-of-way will correspond to the existing location of the road.

Now Therefore, Be It Resolved By The Board of County Commissioners of Weston County, Wyoming:

- 1. Pursuant to Wyoming State Section 24-1-101 there is hereby created and established a portion of the Mush Creek Road, a public highway right-of-way sixty-six feet wide, based upon the common-law doctrines of adverse possession or prescription, as more fully described herein.
- 2. The County Clerk of Weston County, Wyoming, shall publish the following notice for three successive weeks in the Weston County Gazette, an official newspaper published in Weston County, Wyoming, and shall cause the notice to be posted in at least three public places along the line of the proposed road, which notice shall be exclusive of all other notices:

Neiman, Jean Lillian Brunning, Loretta Alice Neubert, Ester Mae Reed, Edgar L. Manaugh AND THEIR UNKNOWN HEIRS, SUCCESSORS AND ASSIGNS AND ALL OTHERS WHOM IT MAY CONCERN:

The Board of County Commissioners of Weston County, Wyoming, has resolved the creation and establishment of a public highway right-of-way sixty-six feet wide under the common-law doctrine of prescription in that the road was constructed or substantially maintained by Weston County, Wyoming, for general public use for a period of ten years or more in Sections 10 and 11, Township 44 North, Range 64

West, 6<sup>th</sup> P.M., Weston County, Wyoming, the centerline of said road commencing at a point in Section 11, Township 44 North, Range 64 West, Weston County Wyoming, which point lies N 52°12'55"E a distance of 1,692.57 feet from the SW corner of said Section 11, and is the point of beginning.

Thence N 66°54'25"W for a distance of 419.74 feet;

Thence through a curve to the left, with central angle 30°10'17", Radius 1010.65 feet for a distance of 532.20 feet;

Thence S 82°55'18"W for a distance of 320.75 feet;

Thence through a curve to the left, with central angle 1°43'50", Radius 4204.73 feet for a distance of 127.01 feet;

Thence through a curve to the left, with central angle 5°55'03", Radius 4204.73 feet for a distance of 434.27 feet;

Thence S 75°16'25" W for a distance of 2030.91 feet;

Thence S 75°45'08"W for a distance of 270.83 feet to a point on the West boundary of the SE¼ of Section 10, Township 44 North, Range 64 West, Weston County Wyoming, and the point of termination.

All objections thereto must be filed in writing with the Weston County, Clerk before noon on the 14th day of June \_\_\_\_, A.D. 2004, or such road will be established without reference to such objections. The Board of County Commissioners Weston County, Wyoming, will consider the creation and establishment of said road at 2:00 o'clock P.M. on the 15th day of June \_\_, A.D. 2004, in the Board meeting room, Weston County Courthouse, 1 West Main, Newcastle, Wyoming

- 3. The Board of County Commissioners of Weston County, Wyoming, shall mail a copy of the above notice by registered or certified mail to all persons owning lands or claiming any interest in any lands over and across which the road is proposed to be created or established, at least 30 days before the Board considers the creation and establishment of the road as set forth above.
- 4. The Weston County Clerk shall keep a record of the number and the location of the notices posted along the line of the proposed road, and a record of the mailing of the notice to all persons entitled to receive such notice as set forth herein.
