RESOLUTION FOR THE VACATION OF STREETS AND ALLEYS IN OSAGE, WYOMING

WHEREAS the Board of Weston County Commissioners, acting on a request received from the Osage Improvement and Service District (OISD), have taken action in a meeting held June 5, 2012, to vacate portions of dedicated streets and alleys as platted in the unincorporated town of Osage, Nefsy Addition, Weston County, Wyoming, and

WHEREAS the owner of record is the Osage Improvement and Service District, Inc., P.O. Box 44, Osage, Wyoming 82723, and the listed streets and alleys to be vacated are within or connected to the property know as the Kitty Moats School, and

WHEREAS notice of the intended action was published three times as required by law, and

WHEREAS the date for objections having been set, and no objections or claims for damages having been received by the Weston County Board of Commissioners, and

WHEREAS this vacation pertains to the portion of land listed below:

A sixty (60) foot wide street known as Barton Street commencing at the southwest corner of block 27 running east thence to the southeast corner of block 26 running south thence to the northeast corner of block 19 running west to the northwest corner of block 18 running north thence and terminating at the southwest corner of block 27; and

A forty (40) foot wide street known as Mondell Ave. commencing at the southeast corner of block 18 running north thence to the northeast corner of block 27 running east thence to the northwest corner of block 26 running south thence to the southwest corner of block 19 running west thence and terminating at the southeast corner of block 18; and

A ten (10) foot alley commencing at the northeast corner of lot 1 block 18 running south thence to the southeast corner of lot 12 block 18 running east thence to the southwest corner of lot 24 block 18 running north thence to the northwest corner of lot 13 block 18 running west and terminating at the northeast corner of lot 1 block 18; and

A ten (10) foot alley commencing at the northeast corner of lot 1 block 27 running south thence to the southeast corner of lot 12 block 27 running east thence to the southwest corner of lot 24 block 27 running north thence to the northeast corner of lot 13 block 27 running west and terminating at the northeast corner of lot 1 block 27; and

A ten (10) foot alley commencing at the northeast corner of lot 1 block 19 running south thence to the southeast corner of lot 12 block 19 running east thence to the southwest corner of lot 24 block 19 running north thence to the northeast corner of lot 13 block 19 running west and terminating at the northeast corner of lot 1 block 19; and

A ten (10) foot alley commencing at the northeast corner of lot 5 block 26 running south thence to the southeast corner of lot 12 block 26 running east thence to the southwest corner of lot 24 block 26 running north thence to the northeast corner of lot 17 block 26 running west and terminating at the northeast corner of lot 5 block 26.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weston County, Wyoming, that the portions of streets and alleys described above are vacated and closed effective immediately; and a copy of this resolution shall be filed with the County Clerk of Weston County, Wyoming.
