the Board of County Commissioners of Weston County, Wyoming, deem that WHEREAS, a portion of Wyoming State Highway Projects NRS-276 and State Project 2036, Upton-Sundance Road described as follows:

All that portion of the $SE_Z^1SE_Z^1$ of Section 6, $NE_Z^1NE_Z^1$ of Section 7, $NW_Z^1NW_Z^1$ of Section 8, and the $SW_Z^1SW_Z^1$ of Section 5, all of T. 48 N., R. 64 W. of the 6th P.M., Wyoming, being described by metes and bounds as follows:

Commencing at the corner common to said Sections 6, 7, 8 and 5;

thence N.0°14'W. along the east boundary of said Section 6 a distance of 147.9 feet to the True Point of Beginning, said point of beginning also being located on the north right-of-way boundary of old Wyoming State Highway Number 116 (Wyoming Highway Department Project Number NRS-278);

thence 89°58'E. along said right-of-way boundary a distance of 1,654.66 feet to the point of beginning of a circular curve concave southerly, the radius of which is

3,894.72 feet;

thence southwesterly along said curve through a central angle of 49°35' a distance of 3,370.48 feet to the point of ending of said curve;

thence N.40°43'43.15"E. a distance of 136.99 feet to the point of beginning of a

circular curve concave westerly, the radius of which is 5,654.72 feet;

thence northerly along said curve and along the westerly right-of-way boundary of said Wyoming State Highway Number 116 through a central angle of 5°10' a distance of 509.90 feet to the point of ending of said curve;

thence N.35°16'E. along said westerly right-of-way boundary a distance of

1,519.3 feet;

thence S.54°44'E. along the northerly right-of-way boundary of said Wyoming State Highway Number 116 a distance of 150 feet;

thence S.35°16'W. along the easterly right-of-way boundary of said Wyoming State

Highway Number 116 a distance of 355.0 feet;

thence N.89°58'E. along the north right-of-way boundary of said Wyoming State Highway Number 116 a distance of 112.94 feet, more or less, to the point of beginning.

The above described parcel of land contains 13.45 acres, more or less. being no longer necessary for state highway purposes, would, in the best interest of the public, be a necessary and extention of the Weston County Road System.

NOW, THEREFORE BE IT RESOLVED, that the said Board of County Commissioners do hereby declare that Weston County will assume all responsibility with regard to repair, service and maintenance of the above described portions of said projects upon relinquishment by the Wyoming State Highway Commission.
