

Set Officials Salaries

WHEREAS, Wyoming Statute requires that county officials' salaries be set by June 1, 1998, for the next four-year terms, and

WHEREAS, the Commissioners met in session on May 7, 1998, and by motion established the salaries listed below.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Weston County Commissioneers declare the following salaries for the elected officials for Weston County for the term beginning the first Monday in January, 1999 and ending the first Monday in January, 2003 to be established.

County Commissioners

\$600.00 salary per month and \$75.00 per day for each official meeting day plus benefits as stated.

The benefits are: payment of 75% of official's portion of the health insurance and 25% of the non-official's or family portion of the health insurance. And for State retirement benefit: county paying 5.68% of the gross salary or the county portion as established by the legislature and also paying 5.57% of the official's portion of the gross salary.

County Assessor, County Clerk, Clerk of District Court, County Treasurer

\$30,000.00 annually plus benefits as stated to be paid in equal monthly installments.

The benefits are: payment of 75% of official's portion of the health insurance and 25% of the non-official's or family portion of the health insurance. And for State retirement benefit: county paying 5.68% of the gross salary or the county portion as established by the legislature and also paying 5.57% of the official's portion of the gross salary.

Sheriff

\$32,000.00 annually plus benefits as stated to be paid in equal monthly installments

The benefits are: payment of 75% of official's portion of the health insurance and 25% of the non-official's or family portion of the health insurance. And for State retirement benefit: county paying 5.68% of the gross salary or the county portion as established by the legislature and also paying 5.57% of the official's portion of the gross salary.

Justice of the Peace

\$15,000.00 annually plus benefits as stated to be paid in equal monthly installments.

The benefits are: payment of 75% of official's portion of the health insurance and 25% of the non-official's or family portion of the health insurance. And for State retirement benefit: county paying 5.68% of the gross salary or the county portion as established by the legislature and also paying 5.57% of the official's portion of the gross salary.

County Attorney

to set the position of county attorney as part-time and to set the salary of the part-time county attorney at \$26,500.00 annually plus benefits to be paid in equal monthly installments for the next four calendar years. The benefits are: payment of 75% of official's portion of the health insurance and 25% of the non-official's or family portion of the health insurance. And for State retirement benefit: county paying 5.68% of the gross salary or the county portion as established by the legislature and also paying 5.57% of the official's portion of the gross salary.

County Coroner

No salary, expenses only and health insurance benefit.

The benefit is: payment of 75% of official's portion of the health insurance and 25% of the non-official's or family portion of the health insurance.
