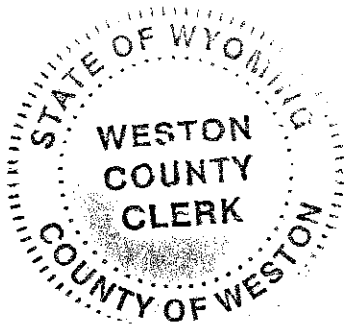
OPEN BURNING RESTRICTIONS LIFTED
