WESTON COUNTY BOARD OF COMMISSIONERS OFFICIAL MINUTES SPECIAL MEETING - APPOINTMENT OF CLERK OF DISTRICT COURT November 22, 2019

The special meeting of the Weston County Board of Commissioners was called to order by Chairman Tony Barton at 4:30 p.m. at the Weston County Courthouse. Commissioners Tony Barton, Marty Ertman, Tracy Hunt, Ed Wagoner and Nathan Todd, and Clerk Becky Hadlock were present. Commissioner Wagoner led the Pledge of Allegiance.

Vice-Chairman moved to remove Melissa Ault from the list of candidates to be interviewed; seconded by Commissioner Todd. During discussion it was discussed that because Melissa was not a registered Weston County republican, at the time she handed in her application to run for this office, she was not qualified to be interviewed for the Clerk of District Court position. Commissioner Todd stated the Board would set a precedence if they allowed her to be interviewed. Commissioner Hunt stated that he felt that they did not have to belong to a party and that this gave the citizens of Weston County more diversity. Ayes: Ertman, Todd. Nays: Barton, Hunt, Wagoner. Failed.

Tina Cote was the first to be interviewed. Vice-Chairman Ertman moved to go into Executive Session per W.S. 16-4-405(a)(ii); seconded by Commissioner Wagoner. Carried. Executive Session began at 4:44 p.m.; regular meeting reconvened at 5:02 p.m. Personnel was discussed in Executive Session; no action was taken.

Vicki Keierleber was the second to be interviewed. Commissioner Todd moved to go into Executive Session per W.S. 16-4-405 (a)(ii); seconded by Commissioner Wagoner. Carried. Executive Session began at 5:04 p.m.; regular meeting reconvened at 5:16 p.m. Personnel was discussed in Executive Session; no action was taken.

Commissioner Todd and Vice-Chairman Ertman left the meeting. They did not want to interview Ms. Ault knowing that she was not qualified to be interviewed for this position.

Melissa Ault was the third to be interviewed. Commissioner Wagoner moved to go into Executive Session per W.S. 16-4-405 (a)(ii); seconded by Commissioner Hunt. Carried. Executive Session began at 5:38 p.m.; regular meeting reconvened at 5:51 p.m. Personnel was discussed in Executive Session; no action was taken.

Vice-Chairman Ertman moved to appoint Tina Cote to fill the unexpired term left by Gidget Macke; seconded by Commissioner Todd. During discussion Vice-Chairman Ertman stated she appreciated everyone's patience during this process. Commissioner Wagoner thanked everyone. Chairman Barton stated Ms. Cote had some big shoes to fill. Carried.

With no further business, the meeting was adjourned at 5:56 p.m.

Mr. Barton,

Thanks for the email. I haven't been able to respond until just now. I have copied the Weston County Clerk on this reply so that she is also in the loop. Here are the associated statutes that discuss qualifications as it relates to running for office and being appointed to office. They essentially are one and the same, see below for the statutory references:

Wyo. Stat. § 22-5-204

(a) Repealed by Laws 1991, ch. 243, § 5.

(b) An eligible person seeking nomination or election for a partisan office shall:

(i) Meet all applicable qualifications to be elected to office which are set forth in the United States and Wyoming constitutions;

(ii) Be registered in the party whose nomination he seeks; and

(iii) File an application in substantially the following form:

APPLICATION FOR NOMINATION OR ELECTION BY PARTY PRIMARY State of Wyoming

County of.....

SS

I, , swear or affirm that I was born on

, (year), that I have been a resident of the state of Wyoming since

, and that I am a registered voter of Election District No. , in , residing at , in County of Precinct No.

, (if for the office of state senator or representative) in Senate (House) , state of Wyoming, and registered as a member of District

party, and I hereby request that my name be printed upon the official party ballot at the next primary election as a candidate for the office , and hereby declare that if nominated and elected, I will of qualify for the office."

Qualifications for appointment:

Wyo. State. § 22-18-11(a)(ii)

"[c]ounty central committee shall select and transmit to the board of county commissioners the names of three (3) persons qualified to hold the office." [Emphasis added]

Wyo. Stat. § 22-18-111(c)(ii)

"Qualified to hold the office" means a person meets all applicable qualifications to be elected to a public office which are set forth in the United States and Wyoming constitutions and Wyoming law, as applicable, on the date of the person's appointment to the public office. [Emphasis added]

Dear Chairman,

Kai

I am writing to provide my opinion on this issue that has come up regarding the vacancy of the Clerk of District Court. The Republican Committee has submitted three names. One of those individuals is not registered to vote and is not a registered republican.

The Board does not have to interview this person. The board, under W.S. 22-18-111(a)(ii), must choose one of these three people. The Board may or may not interview these three people. The Board can use whatever process it deems fit. The issue of qualification may be a factor the Board uses, but the person must be qualified to hold office when appointed (W.S. 22-18-111(c)(ii)). There is no reason I can find why this person cannot register today and be eligible.

I hope this resolves the issue.
