OLD BUSINESS:

1. Corona Virus (Covid-19) Update
 - a. Received the Twentieth Continuation from the State on 1/21/2021.
 - b. Weston County has 518 lab confirmed cases, 0 lab confirmed cases in the past 24 hours, 2 active lab confirmed cases, 92 probable cases. 597 total cases recovered, 512 lab confirmed cases recovered and 85 probable cases recovered. 4 COVID-19 related deaths as of 1/24/21.

 - a. On hold until we can train

 - a. Radios for Upton are in Casper waiting for state IDs

NEW BUSINESS:

1. Dispatch Communications
 - a. There are issues with the radios crashing and causing safety concerns.
 - i. 2 recent situations where the radios weren't working and could have resulted in a dangerous situation for officers.
 - ii. Current CAD software is from 20005 and is outdated.
 - b. Quote from Motorola for handhelds, car, full radio replacement, 2 dispatch stations, records management and software that can be WyoLink or analog.
 - c. Suggested to have a communications committee with each entity represented, or have an executive meeting after LEPC meeting to discuss options.
 - d. Looking at different options for payment. The city is looking at SLIB grant, and they were turned down Cares Act money.
 - e. Don will look at percentages of usage to determine how to split up costs.

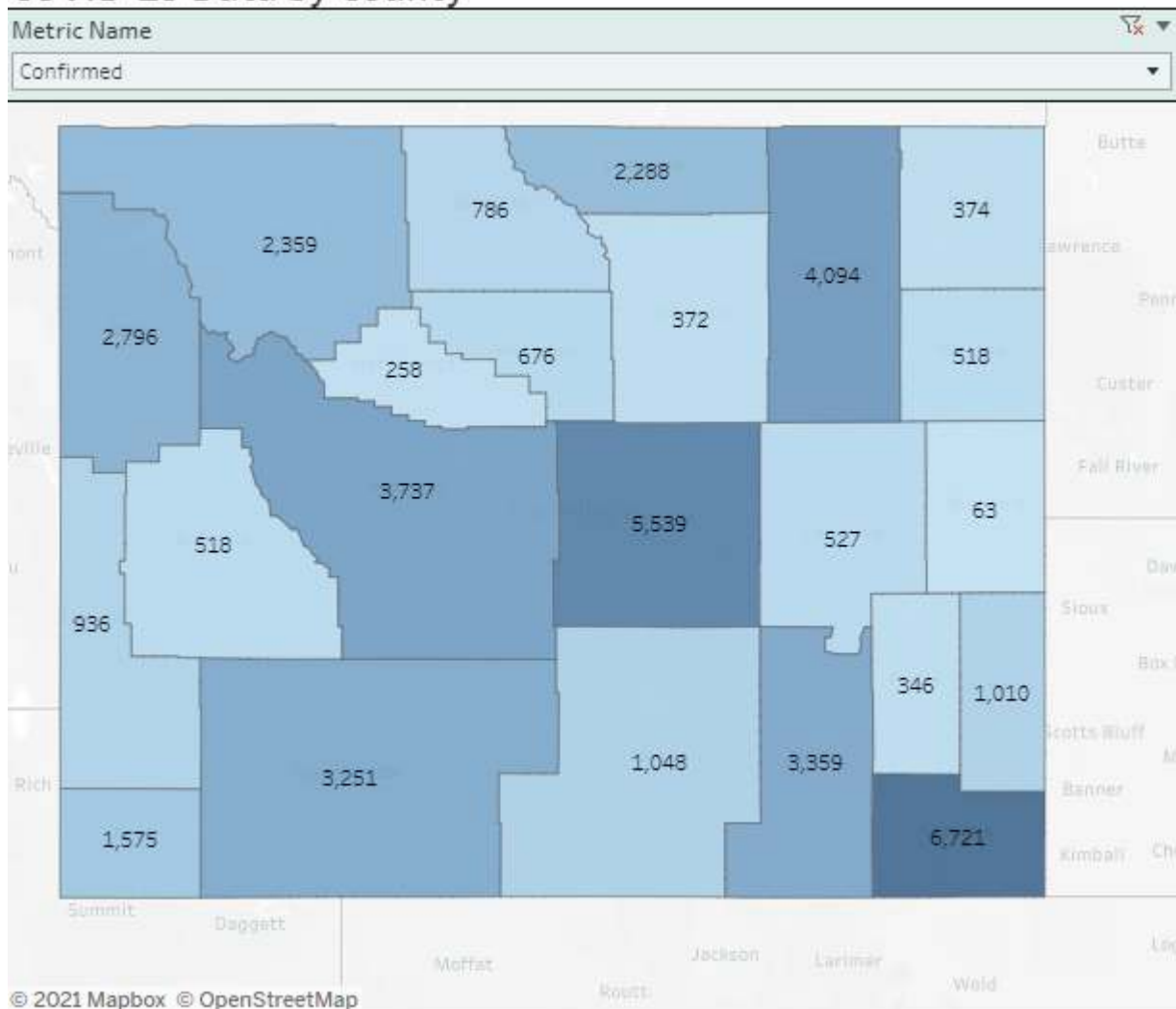

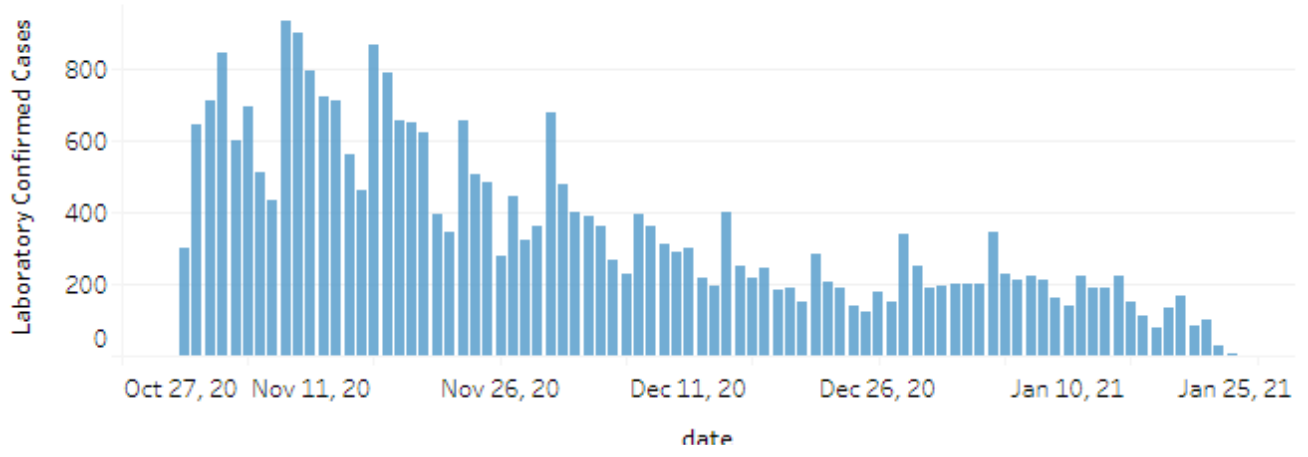
