OLD BUSINESS:

1. Corona Virus (Covid-19) Update
 - a. Weston County has 536 lab confirmed cases, 0 lab confirmed cases in the past 24 hours, 2 active lab confirmed cases, 96 probable cases. 529 total cases recovered, 625 lab confirmed cases recovered and 96 probable cases recovered. 5 COVID-19 related deaths as of 3/30/21.
 - b. Lori update: Vaccinations 1800 doses for first dose, have vaccinated 1405. Second doses 1600, vaccinated 1095. Received 100 doses of Johnson & Johnson and gave 101 doses. 21% of people vaccinated. 80-90% would be ideal, but current goal is 50%. There is a decreased interest at this time.
 - c. When vaccinating there are 10 known doses in the bottle and have to try to schedule to use all of the doses.
 - d. Need more data on the vaccines before the interest will go up.
 - e. Trials are in process for kids' vaccinations.
2. WyoLink Tower Update
 - a. Working on access still, have a verbal agreement with one landowner but still unable to contact the second landowner.

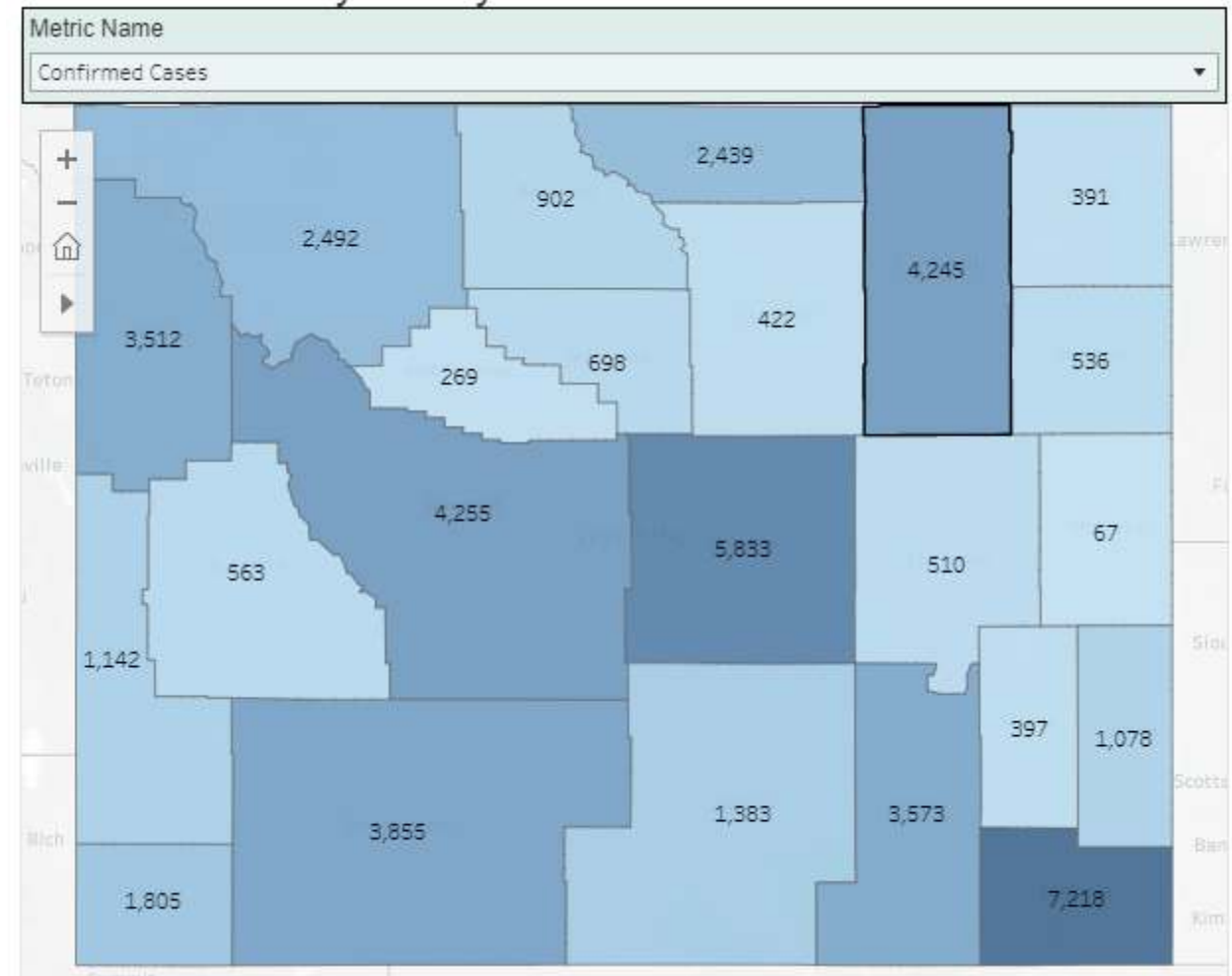

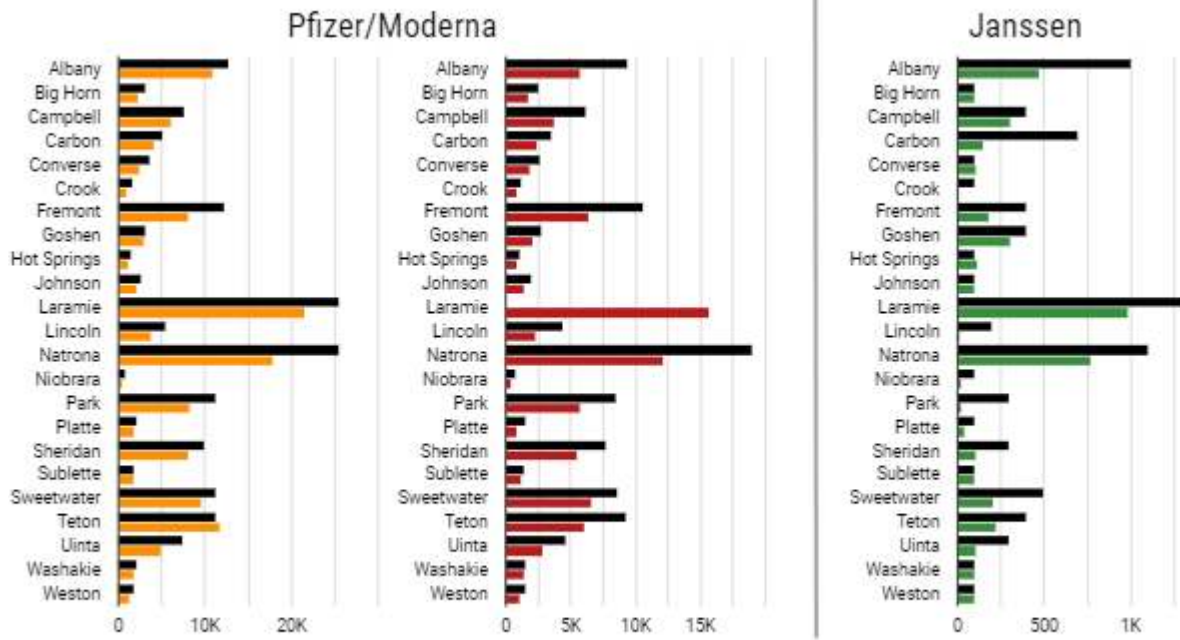
