WESTON COUNTY BOARD OF COMMISSIONERS OFFICIAL MINUTES July 6, 2021

The regular meeting of the Weston County Board of Commissioners was called to order by Chairwoman Marty Ertman at 9:00 a.m. at the Weston County Courthouse. Commissioners Marty Ertman, Ed Wagoner, Nathan Todd, Tony Barton, and Don Taylor, Clerk Becky Hadlock and Deputy Attorney Michael Stulken were present. Commissioner Wagoner led the Pledge of Allegiance.

APPROVAL OF AGENDA

Commissioner Ertman asked to add the Cleaning Contract under 11:00 a.m. for discussion. Commissioner Barton moved to approve the agenda with changes; seconded by Commissioner Taylor. Carried.

APPROVAL OF CONSENT AGENDA

Carried.

Linda-Rose Myers & Todd Kenner gave a power point presentation on EcoTech Fuels to the Board.

OPENING OF CAD BIDS

There was one bid submitted for the replacement of the CAD System. Chairman Ertman opened the Bid at 10:30 a.m. which was from Motorola Solutions. The Bid submitted for the CAD system was for \$330,972 or \$629,159 which included all equipment, two spare consoles and the CAD System. Kevin Parker, with Motorola Solutions addressed the two spare consoles that were added to the bid. Commissioner Barton moved to award \$589,185 to Motorola contingent on approval from the other entities; seconded by Commissioner Wagoner. During discussion Vice-Chairman Todd asked if the current radios would work with the new system and Mr. Parker stated they would. The Board did not add the spares in the award because they were not put into the bid.

The Board had several questions for Ms. Myers but there was not a lot of time for discussion so a Zoom meeting will be added to the next agenda.

PRELIMINARY APPROVAL – SUNSET RIDGE MAJOR SUBDIVISION

Doug Hudson was asked by the Board to present an updated Natural Resource Report as part of his Major Subdivision application process. Caleb Carter with the Natural Resource District stated there are no changes in the soil. Commissioner Barton moved to approve the preliminary approval for the Sunset Ridge Major Subdivision contingent on Mr. Hudson adding buyers would be responsible for engineered septic systems and providing a copy of the Natural Resource Report to all buyers; seconded by

Commissioner Taylor. Chairwoman Ertman stated the Board would send a letter about the approval with stipulations to the Planning Board. Carried.

FY2022 BUDGET

Commissioner Wagoner moved to approve the FY2022 Budget; seconded by Vice-Chairman Todd. Carried.

EXECUTIVE SESSION

Commissioner Barton moved to go into Executive Session per W.S. 16-4-405(a)(ii); seconded by Vice-Chairman Todd. Carried. Executive Session began at 11:36 a.m.; regular meeting reconvened at 11:45 a.m. Matters concerning the Maintenance Foreman Job were discussed in Executive Session; no action was taken.

Clerk Hadlock will schedule job interviews for July 20th that will be 15 minutes long with 15 minutes in between appointments.

CLEANING CONTRACT

Clerk Hadlock stated that the current cleaning contract fee is \$15 per hour, but is looking to be raised to \$25 per hour. Commissioner Barton made a motion to counter offer at \$20 per hour but willing to accept up to \$25 per hour; seconded by Commissioner Taylor. Carried.
