

**NOW, THEREFORE**, be it resolved that Mitchell H. Damsky or other designee of the Campbell County Attorney's Office be authorized to act as a Special Deputy County Attorney to make proper disposition of all potential criminal and/or civil matters concerning the Concerned Citizens of Weston County, as set forth above on behalf of Weston County, Wyoming.
