WESTON COUNTY BOARD OF COMMISSIONERS OFFICIAL MINUTES May 3, 2022

The regular meeting of the Weston County Board of Commissioners was called to order by Chairwoman Marty Ertman at 9:00 a.m. at the Weston County Courthouse. Commissioners Nathan Todd, Ed Wagoner, Tony Barton and Don Taylor, Deputy Attorney Jeani Stone and Clerk Becky Hadlock were present. Carey Voss led the Pledge of Allegiance.

APPROVAL OF AGENDA

Clerk Becky Hadlock indicated Nicole McFarland would not make it to the meeting. Newcastle Mayor Pam Gualtieri sent an e-mail early that morning and asked to be added to the agenda following Homeland Security Coordinator Gilbert Nelson. The City was added to the agenda at 3:30 p.m. Commissioner Wagoner moved to approve the agenda with changes; seconded by Commissioner Barton. Carried.

APPROVAL OF CONSENT AGENDA

Commissioner Barton moved to approve the Consent Agenda, minus warrants #69223 and #69224, which included the vouchers, payroll, AP vouchers, collections for April 2022, Minutes of April 19, 2022, Special Meeting Minutes of April 26, 2022, Executive Session Minutes of April 26, 2022, Tax Roll Corrections #1505-#1506, Chairman's Signature on Resolution 2022-7 -2022 Election Districts and Precincts for Primary and General Elections, Chairman's Signature on Resolution 2022-8 — Amendment to the 2021-2022 Budget, Board's Signature on National Preservation Month Proclamation; seconded by Commissioner Wagoner. Carried.

Commissioner Barton moved to pay warrant #69223 with changing the total from \$21,906 to \$20,728 and changing the deductible; seconded by Commissioner Wagoner. Carried.

Commissioner Barton moved to accept warrant #69224 pending signature by a current Board member; seconded by Commissioner Wagoner. Carried.

PUBLIC HEALTH

Weston County Nurse Manager Sarah Gregory and Public Health Response Coordinator Christia Ault came before the Board to discuss the amended contract for the PHRC contract position. Commissioner Barton moved to authorize the Chairman's signature on Amendment One to the Contract between Wyoming Department of Health, Public Health Division and Weston County; seconded by Commissioner Taylor. Carried.

ROAD & BRIDGE

Commissioner Barton moved to authorize the Board's signature on the Eligibility Certificate form for Old Hwy 85 Bridge Bros Project; seconded by Vice-Chairman Todd. Carried. Road & Bridge Superintendent Jim Hansen let the Board know that the State denied the bid for CMAQ Project. Commissioner Barton moved to table this to the next meeting; seconded by Vice-Chairman Todd. Carried. Superintendent Hansen stated the project on Dewey Road can be 100% federally funded. Commissioner Wagoner moved to halt engineering processes on Dewey Road Bridge and move forward with WYDOT 100% replacement; seconded by Commissioner Barton. Discussion ensued. Carried.

ROAD NORTH OF CITY OF NEWCASTLE BY OLD WATER TANK

Discussion ensued on the Road North of Newcastle by the old water tank. The Board would like Tim Ottaway to do a petition to start the process and bring this to the Board.

DISCUSSION USING TELEPHONE LINE FROM LAW ENFORCEMENT BUILDING TO CITY HALL

City Engineer Mike Moore, Mayor Gualtieri and Newcastle Police Chief Sam Keller came before the Board to discuss the current Communication tower located at the County Law Enforcement Center. The Board would like to visit with the Sheriff and discuss this at the next meeting.

Dru Palmer, with Dru Consulting phoned in to update the Board on the Natural Resource Plan the Black Hills National Forest Plan and the BLM Resource Revision Plan.

Commissioner Barton moved to authorize Deputy Attorney Stone to engage Tucker Ruby as legal Counsel; seconded by Vice-Chairman Todd. Carried.

LE RAMP UPDATE

Nick White with White Construction came before the Board with updated plans on the elevator for the Law Enforcement Building. Commissioner Wagoner moved to authorize White Construction to put an elevator in at the Law Enforcement for \$340,196.04; seconded by Commissioner Taylor. Carried.

ELECTED OFFICIALS SALARY & EMPLOYEE SALARY DISCUSSION

Commissioner Barton moved to authorize a 15% COLA adjusting all hourly and salary employees effective on the next pay period; seconded by Commissioner Wagoner. Discussion ensued. Carried.

Commissioner Barton moved to set the County Clerk, Treasurer, Assessor & Clerk of District Court salaries at \$65,000, the Sheriff & County Attorney at \$70,000, the County Commissioners & Coroner at \$15,000; seconded by Vice-Chairman Todd. Discussion ensued. Ayes: Barton Nays: Ertman, Todd, Wagoner, Taylor. Failed.

Commissioner Wagoner moved to set the County Clerk, Treasurer, Assessor & Clerk of District Court at \$69,000, the Sheriff & County Attorney at \$75,000, the County Coroner at \$16,500 & the Commissioner at \$14,400; seconded by Commissioner Todd. Carried.

DISPATCH

Commissioner Wagoner made a motion to move forward with the Motorola equipment with the Sheriff running dispatch with a Joint Powers Board in place, once the equipment arrives, with representation of all entities involved; seconded by Vice-Chairman Todd. Discussion ensued. Carried.
