#### **OLD BUSINESS:**

### 1. WyoLink Tower Update

a. Mike Moore has reported a draft lease has been put together by WYDOT and hopes to have this finalized Clay Anderson bought the southbound property from Charles Marten all the way down the hill and ending at the eastern boundary of Frontier Addition and south towards the Fairgrounds.

#### 2. Dispatch Communications

a. Ongoing with each group. There is a special County Commissioners meeting scheduled for 4.26.22 at 9:00 am.

It was decided at this meeting that the County Attorney (Jeani Stone) would find 3 mediators. The City Council, Count y Commissioners, and the Upton Town Council would choose one to hire and work towards a Joint Powers Board. The cost of the mediator would be paid for by the County. There was a representation of citizens at the meeting that were mostly opposed against there being 2 separate dispatch centers. A contract for services was presented to the Commissioners by the Newcastle Mayor. The contract was a draft and had not been approved by the City attorney. The contract was not discussed.

# 2. Wyoming Refining Company SO2 Report that occurred on 4.1.2022.

Don Steveson discussed the release of the Sulphur Dioxide and opened up ALOHA and explained how and what information was entered into the program and how it helped track the release and the information available to help determine mitigation through mapping and models. (See attached reports)

3. Looking to replace the sirens around town and move the one at the fire hall

The siren at the fire hall will be moved over by the Children's Center for better coverage. Don Steveson showed maps that indicated the coverage of the current sirens and the decibels. Coverage is 800 feet at 90 decibels. Don Steveson. advised that Emergency Management/HLS will be purchasing 2 new sirens that they got through a grant and the coverage for the new sirens reaches 100-110 decibels.
