# WESTON COUNTY BOARD OF COMMISSIONERS OFFICIAL MINUTES September 6, 2022

The regular meeting of the Weston County Board of Commissioners was called to order by Chairwoman Marty Ertman at 9:00 a.m. at the Weston County Courthouse. Commissioners Ed Wagoner, Tony Barton and Don Taylor, Attorney Michael Stulken and Clerk Becky Hadlock were present. Garrett Borton led the Pledge of Allegiance.

#### APPROVAL OF AGENDA

Commissioner Taylor asked to add Employee Handbook under Old Business. Clerk Hadlock stated Tiffony Riehemann would not be able to attend for the Upton Ambulance but the Board still wanted to have a conversation about this. Commissioner Wagoner moved to approve the agenda with changes; seconded by Commissioner Taylor. Carried.

# **ROAD & BRIDGE**

Road & Bridge Superintendent Jim Hansen let the Board know that it will cost \$17,850 for a new furnace system as the current system cannot be fixed. Commissioner Barton moved to authorize Superintendent Hansen to pursue getting a new heater for the Road & Bridge shop; seconded by Commissioner Taylor. Carried. Superintendent Hansen gave the Board an update on the Road & Bridge Department.

#### **MALLO CAMP**

Mallo Camp Board Member Gideon Dixon, Mallo Camp Manager Caleb Thompson and Natural Resource District Manager Caleb Carter gave a presentation to the Board about timber reduction around Mallo Camp. Mallo Camp has applied for a grant but would need \$20,000 from the County as a match. The Board will have an answer for them by the next meeting.

#### **MUSSER ROAD**

Bev Szuma let the Board know that her and Superintendent Hansen have discussed putting a culvert on Musser Road as a solution to what she was coming in for. The culvert form will be added to the next agenda.

#### **UPTON AMBULANCE**

The Upton Ambulance was discussed and they will be invited to the first meeting in October.

Dru Bower phoned in to give the Board an update on the Black Hills National Forest Land Use Plan, Newcastle BLM Resource Management Plan Revision and the Thunder Basin National Grasslands.
