# WESTON COUNTY BOARD OF COMMISSIONERS OFFICIAL MINUTES June 20, 2023

Commissioner Taylor moved to postpone the Public Hearing with the consent of the Fair Board member to a later date pending Employer's Council investigation; seconded by Commissioner Huber. Carried.
