WESTON COUNTY BOARD OF COMMISSIONERS OFFICIAL MINUTES September 5, 2023

The regular meeting of the Weston County Board of Commissioners was called to order by Chairman Ed Wagoner at 9:00 a.m. at the Weston County Courthouse. Commissioners Nathan Todd, Don Taylor, Vera Huber and Garrett Borton, Attorney Michael Stulken and Clerk Becky Hadlock were present. Commissioner Vera Huber led the Pledge of Allegiance.

APPROVAL OF AGENDA

Clerk Hadlock asked to add two credit card pre-authorization requests and Treasurer's Reports under the Consent Agenda. Commissioner Huber asked to add Title 25 under Old Business.
