# WESTON COUNTY BOARD OF COMMISSIONERS OFFICIAL MINUTES January 2, 2024

The regular meeting of the Weston County Board of Commissioners was called to order by Chairman Ed Wagoner at 9:00 a.m. at the Weston County Courthouse. Commissioners Nathan Todd, Don Taylor, Vera Huber and Garrett Borton, Attorney Michael Stulken and Clerk Becky Hadlock were present. Assistant Publisher/Editor for the *Weston County Gazette*, Nick Trandahl led the Pledge of Allegiance.

### **APPROVAL OF AGENDA**

Chairman Wagoner asked to have the Treasurer's Report pulled from the Consent Agenda. Vice-Chairman Todd asked to pull Notice of Final Payment to Contractor from the Consent Agenda for discussion and asked to add Elevator Ramp under New Business. ## **OFFICIAL NEWSPAPER**

Bids were requested from the two newspapers that are published in Weston County. A specific set of minutes were given to each, requesting submission of a cost per column inch and to include a total cost for publishing that set of minutes. A bid was received from the *Weston County Gazette* in the amount of \$6.00 per column inch with a total cost to publish the sample of \$264.00, with a paid circulation of 632. A quote was received from the *News Letter Journal* in the amount of \$10.50 per column inch with a total cost to publish the sample of \$945.00, with a paid circulation of 1572. Commissioner Wagoner moved to appoint the *Weston County Gazette* as the official Weston County newspaper in 2024; seconded by Commissioner Todd. Discussion ensued. Ayes: Wagoner, Todd, Huber.
