

RESOLUTION 2025-18
AMENDMENT TO THE 2025-2026 BUDGET

WHEREAS, pursuant to Wyoming State Statute §16-4-113, the budget of the General Fund may be changed by resolution of the governing body.

NOW, THEREFORE, BE IT RESOLVED, BY THE GOVERNING BODY OF WESTON COUNTY, WYOMING, that the 2025-2026 County Budget be amended by moving \$2,500.00 from the GEN FINANCE ADMIN ACCOUNT and adding it to 100.00.06.0034000.0000, titled ATTNY OFFICE EQUIP/TECH, which will have an expenditure amount of \$3,000.00, by moving \$3,424.00 from the GEN FINANCE ADMIN ACCOUNT, by adding it to 100.00.07.0039000.0000, titled LAW ENF INMATE PROGRAM, which will have an expenditure amount of \$3,924.00, by moving \$1,000.00 from the GEN FINANCE ADMIN ACCOUNT and adding it to 100.00.05.0051000.0000, titled GEN SHERIFF NEW EQUIP, which will have an expenditure amount of \$1,000.00, by moving \$64.00 from the GEN FINANCE ADMIN ACCOUNT and adding it to 100.00.07.0043000.0000, titled GEN LAW ENF TOWER RENT, which will have an expenditure amount of \$1,464.00, by moving \$1,162.00 from the GEN FINANCE ADMIN ACCOUNT, adding it to 100.00.05.0031000.0000, titled GEN SHERIFF PUB REL, which will have an expenditure amount of \$1,162.00 and by moving \$250.00 from the GEN FINANCE ADMIN ACCOUNT and adding it to 100.00.07.0014000.0000, titled GEN LAW MAINT AGRMNT, which will have an expenditure amount of \$1,000.00 and by adding \$20,461.57 to 100.00.20.0104000.0000, titled GEN MISC NOAT, for unanticipated revenue.



WHEREAS the Board of Commissioners resolves to amend the 2025-2026 budget with an effective date of August 19, 2025.


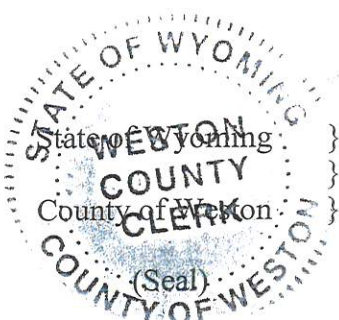
