

**WESTON COUNTY BOARD OF COMMISSIONERS  
OFFICIAL MINUTES  
December 2, 2025**

The regular meeting of the Weston County Board of Commissioners was called to order by Vice-Chairman Ed Wagoner at 9:00 a.m. at the Weston County Courthouse. Commissioners Garrett Borton and Marty Ertman and Clerk Becky Hadlock were present. Commissioner Borton opened the meeting with prayer, and Clerk Hadlock led the Pledge of Allegiance.
