

**RESOLUTION NO 2026-17**  
**ADOPTING FEES AND BILLING SCHEDULE FOR HOME VISITATION SERVICES**

WHEREAS, Weston County, Wyoming has established a county health department and a County Public Health Officer has been appointed pursuant to W.S. 35-1-305(a); and

WHEREAS, W.S. 35-1-306(e) grants the Weston County Board of Commissioners the authority to fix reasonable fees and charges for services provided by the Weston County Public Health Department; and

WHEREAS, W.S. 35-27-101 through 104 establishes a home visitation program to be administered by the Weston County Public Health Department; and

WHEREAS, pursuant to the authority granted to the Weston County Board of Commissioners pursuant to W.S. 35-1-306(e), the Weston County Board of Commissioners desires to adopt a fee and billing schedule for the home visitation program established by W.S. 35-27-101 through 104, as administered by the Weston County Public Health Department, to the extent allowed by law;

**THEREFORE BE IT RESOLVED** by the Board of County Commissioners in and for Weston County, Wyoming that:

1. The fee and billing schedule for the Weston County Public Health Department's administration of the home visitation program established pursuant to W.S. 35-27-101 through 104 shall be and shall mirror the fee and billing schedule for Medicaid reimbursements, as those fees change from time to time, with the current schedule being attached hereto as Exhibit "A", incorporated herein. It is understood that the Medicaid billing and fee schedules change from time to time and the fees for this program shall change as those fees change.

2. Said fee and billing schedule shall only be utilized for the purposes of seeking reimbursement from Medicaid and/or private insurance carriers while services are provided in the administration of said home visitation program and, pursuant to law, said home visitation program shall be administered at no costs to participants of the home visitation program.
